Reference is made to your application received on February 26, 2013.

You have requested to amend Administrative Order NSP-1400, issued on August 15, 1983, to abolish two non-standard, 160-acre gas spacing and proration units approved by that order, consisting, respectively, of the NW/4 and SE/4 of Section 30, and to establish the Subject Units as standard, 320-acre gas spacing and proration units in the Subject Pool.

Your application has been duly filed under the provisions of Division Rules 19.15.15.11.B(2) NMAC and 19.15.4.12.A(3) NMAC.

We understand that ownership of all interests in the oil and gas estate in all of Section 30 is identical.

It is also understood that you have given due notice of this application to all persons to whom notice is required by Rule 4.12.A(3).

Pursuant to the authority conferred by Division Rule 19.15.15.11.B(2), the above-described non-standard gas spacing and proration units in Section 30, established by Administrative Order NSL-1400, and any and all other existing non-standard gas spacing and proration units in the Subject Pool in Section 30, are hereby abolished.

Establishment of the Subject Units as standard, 320-acre gas spacing and proration units in the Subject Pool is hereby approved.

The N/2 of Section 30 shall be dedicated to the following wells:

Jicarilla Contract 155 Wells No. 16M (API No. 30-039-29995) located 760 feet FNL and 2570 feet FWL (Unit C) of Section 30;

Jicarilla Contract 155 Wells No. 30 (API No. 30-039-22570) located 1120 feet FNL and 820 feet FWL (Unit D) of Section 30; and

Jicarilla Contract 155 Wells No. 34 (API No. 30-039-23412) located 1060 feet FNL and 870 feet FEL (Unit A) of Section 30.

The S/2 of Section 30 shall be dedicated to the following wells:

Jicarilla Contract 155 Wells No. 13M (API No. 30-039-22347) located 1560 feet FSL and 790 feet FWL (Unit L) of Section 30;

Jicarilla Contract 155 Wells No. 13N (API No. 30-039-29936) located 1550 feet FSL and 1810 feet FWL (Unit K) of Section 30; and

Jicarilla Contract 155 Wells No. 25 (API No. 30-039-22487) located 1080 feet FSL and 1570 feet FEL (Unit O) of Section 30.

This approval is subject to your being in compliance with all other applicable Division rules, including, but not limited to Division Rule 5.9 [19.15.15.9 NMAC].

Jurisdiction of this case is retained for the entry of such further orders as the Division may deem necessary.
