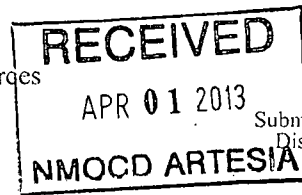

Release was from a water leg on a produced water tank that broke due to high winds. All produced water contained within lined/bermed battery. Vacuum trucks called to recover produced water.

Describe Area Affected and Cleanup Action Taken.*
An approximate area of 6' X 250'. All released produced water contained within lined/bermed battery. Liner intact and all standing fluid recovered with remaining fluid entrained in gravel. Gravel to be removed, disposed at an OCD approved site, and replaced. **Depth to Ground Water: <100'**

(approximately 70', Section 27-T16S-R27E, per NMOSE), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 20. Based on recovered amounts of produced water, release within lined/bermed containment area, disposal of impacted gravel at an OCD approved site, Yates Petroleum Corporation requests closure.
