Reference is made to your non-standard location application received on June 4, 2013. You have also requested a non-standard gas spacing and proration unit for this well. That application is addressed separately by Administrative Order NSP-1968.

You have requested to drill this horizontal well at an unorthodox gas well location described above in the referenced pool or formation. This location is governed by statewide Rule 15.9.A [19.15.15.9.A NMAC], which provides for 320-acre units in the Wolfcamp, with wells located at least 660 feet from a unit outer boundary, and Rule 16.14.B(2) [19.15.16.14.B(2) NMAC] concerning directional wells in designated project areas. This location is unorthodox because portions of the proposed completed interval are less than 660 feet from an outer boundary of the project area.
