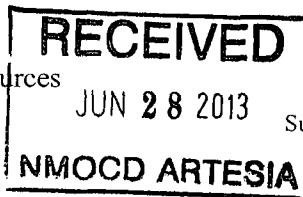

Describe Cause of Problem and Remedial Action Taken.*

Release was caused by a lightning strike that hit the produced water tank. Emergency units were dispatched to control the fire. Vacuum trucks were dispatched to recover standing fluid. The fire and all lost fluid were contained within the bermed battery. The berm was lined and maintained its integrity throughout the incident.

Describe Area Affected and Cleanup Action Taken.*

No soils were affected beyond the secondary containment. The secondary containment constructed for the tank battery was successful in containing all released fluid. Due to the nature of the fire and the damaged equipment, all metal within the berm will be scrapped. Soil and gravel will be removed from the secondary containment and disposed at an NMOCD approved facility. YPC will construct a new facility in place of the old one. **Depth to Ground Water: <100' (approximately 75', Section 21-T21S-R28E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0.**
