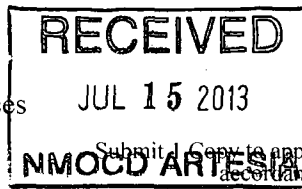

Approximately 1000 sq. ft of the rawhide road and approximately 500 sq. ft. of pasture. All of the spilled fluid soaked into the ground, the spill area will be remediated in accordance to the NMOCD and BLM guidelines.
