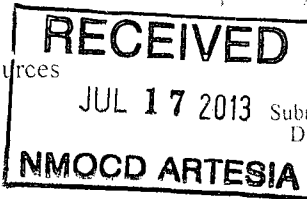

While making daily rounds, pumper discovered hole in fire tube of heater treater. An estimated 30 bbls of oil and water mix (approx 25 BW + 5 BO) was released. All fluid released was contained within the dike. Vacuumed up all fluid possible and dispose of at an approved disposal facility. Repair heater treater. Will dig out contaminated soil, dispose of at Lea Land and replace with clean soil from a nearby source. Soil samples will be taken for analysis.
