
Describe Cause of Problem and Remedial Action Taken.*

Tank ran over, timer on pumping unit didn't shut off was the cause of the release. The well was shut in/unit turned off. Vacuum truck and crew to scrap up impacted soils was called to the location.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 4' X 25'. Impacted soils scraped up/hailed. Depth to Ground Water: >100' (approximately 150', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on remedial/clean up actions, Yates Petroleum Corporation requests closure.
