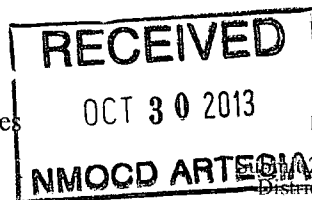

A gasket blew out on a heater treater, causing release (oil and produced water spray). Vacuum truck & roustabout crew called. Valves closed going to heater.

Describe Area Affected and Cleanup Action Taken.*
Area approximately 100' X 80', vacuum truck picked up oil and produced water, impacted pasture area fenced off, back dragged and Micro Blaze sprayed. Pasture will be monitored/checked next spring (2014) to see if any further remediation or revegetation work is needed. **Depth to Ground Water: 50-99' (approximately 95' per New Mexico Office of the State Engineer), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10. Based on cleanup actions taken, Yates Petroleum Corporation requests closure.**
