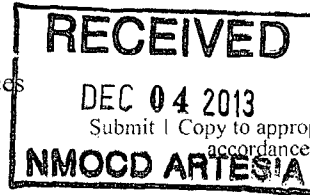

The affected area is approximately 25' x 25' on location. Remediation will be completed in accordance with a remediation plan approved by NMOCD and the BLM.
