

If a Watercourse was Impacted, Describe fully * Produced fluids exited location and flowed into Little Water Draw, an ephemeral water course that runs only during precipitous events.

Describe Cause of Problem and Remedial Action Taken.* The transmitter froze causing the water tanks to overflow. It resulted in a release of 200 barrels of mixed fluids. Emergency response included immediate shut-in of the tank battery and vac trucks on site to pick up all standing fluids. They recovered 160 barrels of mixed fluids. The transmitter was replaced. Talon/LPE was contacted to complete the site assessment and collect soil samples.

Describe Area Affected and Cleanup Action Taken.* The area impacted was inside of the earthen berm surrounding the tank battery, 80'x150' and off the north side of location.
