Dear Mr. Brooks:

Texland Petroleum-Hobbs, LLC ("Texland") hereby seeks administrative approval pursuant to NMAC 19.15.15.13 for an unorthodox well location for its *Simmons Estate #2* well (the "Well"). The Well will be drilled to the Strawn formation, which is governed by state rules providing for 80 acre spacing units. The rules also provide for orthodox well locations at least 100 feet from the center of any one of the quarter/quarter spacing units included in the 80 acre spacing unit.

The proposed spacing unit for the Well is as follows:

Township 17 South, Range 37 East, NMPM, Lea County, New Mexico
Section 3: N/2SW/4 (Units K and L)

In this case, the Well will be located 350 feet from the east line and 330 feet from the south line of Unit L.

 The unorthodox location is required in this instance because of geologic conditions. The proposed location is positioned to encounter a small Strawn algal mound reservoir at its center and at the highest point possible in order to insure the reservoir is drained optimally. This is reflected on the Strawn Isochron on attached Exhibit A. Because of the limited size of the reservoir, drilling in a location other than the seismic-derived location presents considerable risk of encountering plugged porosity and non-productive pay.









