

Describe Cause of Problem and Remedial Action Taken.*

Gauge cocks did not hold the site glass in place, causing the site glass to break. Replaced gauge cocks and site glass.

Describe Area Affected and Cleanup Action Taken.*

Initially 8bbls of oil and 1bbl of produced water were released due a broken site glass on a separator. We were able to recover 7bbls of oil and 1/2bbl of produced water with a vacuum truck. The spill was contained inside the lined facility. All free fluid has been recovered. Any contaminated gravel has been removed, the liner has been steam cleaned and we has replaced with fresh gravel as necessary. This location has been returned to its prior condition.


