

Suction valve was not open. Make sure all suction valves are open.

Describe Area Affected and Cleanup Action Taken.*

Initially 10bbls of oil were released and 30bbls of produced water were released due to a water tank that over flowed. We were able to recover 8bbls of oil and 28bbls of produced water with a vacuum truck. The spill was contained inside the lined facility. All free fluid has been recovered. Any contaminated gravel has been removed, the liner has been steam cleaned and we has replaced with fresh gravel as necessary. This location has been returned to its prior condition.


