

The failure of a Kimray dump valve on a 3 phase separator caused the tanks to spill 90 bbls of oil onto the ground. 80 bbls of oil were recovered via vacuum truck and the valve was repaired or replaced.

Describe Area Affected and Cleanup Action Taken.*
The affected area is approximately 30' x 90' on location. Remediation will be completed in accordance with a remediation plan approved by NMOCD and the BLM.
