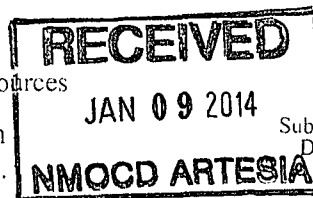

For an unknown reason, a valve was left open, a handle was off, and a bull plug was missing at the well head which caused 7 bbls of oil and 33 bbls of produced water to leak onto the ground. All free-standing fluids were recovered via vacuum truck and the well head parts were repaired and/or replaced.

Describe Area Affected and Cleanup Action Taken.*

The affected area is approximately 10' x 20' on location. Remediation will be completed in accordance with a plan approved by NMOCD.

On behalf of Oxy, this is to inform you Oxy Permian Primary NM North had a release at the Roo 22 State 013 on December 28, 2013. Oxy released 7 bbls of oil and 33 bbls of produced water. Valve was opened by an unknown cause, handle was off and bull plug was missing at the well head. Spill did not leave location and free fluids were picked up. The leak is located in UL C in Sect 22 T17S R28E of Eddy County. API number 30-015-40535. Initial C141 to follow. BBC will delineate at a later date. Driving directions: On Hwy 82 turn north on Hwy 208, go 2.5 miles, location is on the east side of the road.
