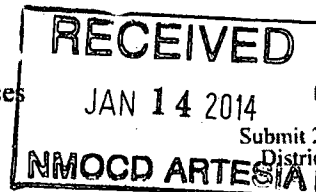

Initially 2bbls of oil and 3bbls of produced water were released. We were able to recover 0bbls of oil and 0bbls of produced water. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOC D for approval prior to any significant remediation work.

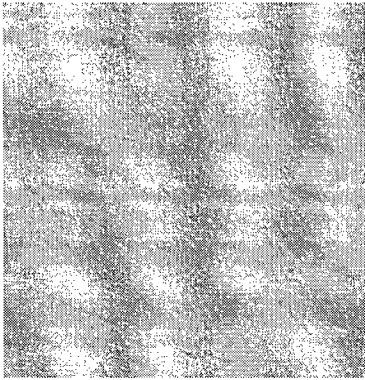
