Faulty drain valve on the trucking off load filter pot and water from gun barrel backed up through the filter pot. Problem has been repaired.
Describe Area Affected and Cleanup Action Taken.*
Tetra Tech personnel inspected the site and collected samples to define the spill extents. Impacted soil exceeding the RRAL and elevated chlorides were removed and transported to proper disposal. Once excavated to the appropriate depths, the excavations were backfilled with clean soil to grade. Tetra Tech prepared a closure report and submitted it to NMOCD for review.
