

A 1" high pressure hose connecting the flow line to the well failed at the coupling. The hose section was replaced.

Describe Area Affected and Cleanup Action Taken.\*  
The spill impacted approximately 22,500 sq.ft. of well pad area and approximately 15,000 sq.ft. of pasture area. The site was cleared by the BLM Arch survey. Basin Environmental began delineation activities on 4/21/14 and started removing impacted soil on 4/22/14. The remediation is in progress. The spill will be cleaned up in accordance to the NMOCD and BLM remediation guidelines.



Ben Arguijo indicated that he spoke to you earlier regarding this site. These maps are supplements to that conversation. Thanks.



