

Over pressure in a 2" steel vent line caused tanks to spill 8 bbls of oil and 5 bbls of produced water to leak onto the ground. No fluids were recovered and the line was repaired or replaced.

Describe Area Affected and Cleanup Action Taken.*
The affected area is approximately 10'x 43' on location. Leak stayed within the facility. Remediation will be performed in accordance with a plan approved by NMOCD and BLM.

This is to inform you that Oxy Permian Primary NM South had a release at the Patton 17 Federal #1 CTB on April 22, 2014. Oxy released 8 bbls of oil and 5 bbls of produced water due excessive pressure in 2" steel vent line causing tanks to spill over. No fluids were recovered. The release is located in Section 17, T24S, R31E of Eddy County, NM. BBC International will remediate the location at a later date and an initial C-141 will follow. Driving directions: On NM 128 East at Mile Marker 13, turn South on Twin Wells Road and go 5.5 miles, road curves West and turns to caliche, follow the road to the 2nd battery on the South side of the road.
