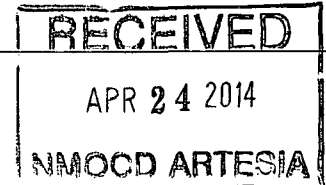

Describe Cause of Problem and Remedial Action Taken.\* The release was discovered during routine inspection of the well pad. The well has been shut in since 3/8/13

Describe Area Affected and Cleanup Action Taken.\* The release impacted approximately 18,200 sq.ft. of the caliche well pad. During initial response activities, berms were installed to prevent the fluid from leaving the well pad onto the recently downsized area around the pad. The Pierce Canyon 17-24-30 USA #1H release site was remediated as per NMOCD and BLM recommended guidelines. Soil samples collected from the floor and sidewalls of the excavation were analyzed by an NMOCD-approved laboratory, which determined concentrations of BTEX, TPH and chloride were less than NMOCD regulatory standards in each of the submitted soil samples. Please reference the attached *Remediation Summary and Site Closure Request* for complete remediation details.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment.
