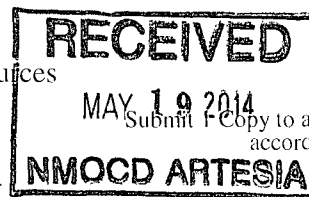


High flow rate of oil coming in and failure to close thief hatch on oil tank allowed oil to be released into secondary containment.

Describe Area Affected and Cleanup Action Taken.*

Affected area- Inside the containment.

Cleanup- Vacuum truck came and sucked up standing fluid from inside the containment (a total of 8 bbls were recovered and taken to Tweedy SWD), pressure washer cleaned of tanks and catwalk. Containment was lined with poly therefore no dig and haul was necessary.
