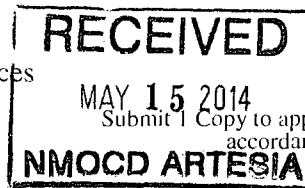

Also backhoe will dig out contaminated soil inside containment and haul off to R360 and clean caliche will be used to backfill.
