**At the Red Bull 31-1, a truck driver from Basic picked up a load of produced water and after loading he did not close the valve on the water tank and the valve at the end of the load line causing 12 barrels of produced water to be released through the load line. The lease operator closed the valves and notified the Assistant Foreman and Basic was called for vacuum services. Approximately 2 barrels of produced water were recovered.**

Describe Area Affected and Cleanup Action Taken.\*

**The area affected within the facility was 81 feet wide by 78 feet long. Talon LPE was contacted to perform the site assessment and soil sampling activities.**
