Describe Cause of Problem and Remedial Action Taken.*

Gasket on the lower manway of the heater treater ruptured causing fluid to spray from the vessel. All free standing fluids picked up and disposed of at an NMOCD approved facility.

Describe Area Affected and Cleanup Action Taken.*

Main impact area was contained within the bermed area. An area approximately 115' x 25' found directly behind the separating equipment received heavier impact. Adjacent to this area is a 335' x 180' area which is low impact spray area. All free fluids have been recovered. COG will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment. Most was contained inside the lines berm. Wind caused a spray of fluid outside berm in the pasture on the north side of the battery. The impacted area is approximately 660 x 150 feet.

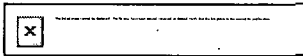
