
Describe Cause of Problem and Remedial Action Taken.*

The gauge on the tubing blew out, causing the release. Gauge repaired; vacuum truck(s) and roustabout crew called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 10' x 60'. Impacted area scraped and excavated soils hauled to a NMOC D approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 10) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the OCD. Depth to Ground Water: 50-99' (approximately 75', Section 4, T24S-R29E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10.
