July 4, 2014 on Todd 22-2 Battery Dumphine on the 2 phase separator plugged and sent all of the fluid to the open top tank and overflowed it. It sent a total of 117 bbl of fluid to the tank. In the tank we had 95 BBL of produced water and 5 BBL of oil. There was 2 barrels of oil and 15 water that overflowed out of the tank.
