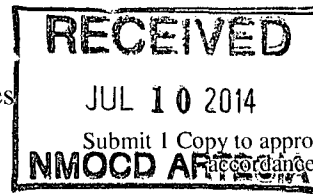

Site glass on separator failed when well pressured up causing oil mist to be sprayed out in the pasture to the Northeast. Separator was isolated to make repairs.

Describe Area Affected and Cleanup Action Taken.*

Affected area- Overspray out into the pasture 300 ft by 100 ft Northeast of the separation equipment. Vegetation was sprayed with Micro Blaze (3% cut).
