Cleanup Action Taken- Vacuum truck picked up all standing fluid (15 bbls) and hauled to Fairchild SWD. Contaminated soil will be dug out and hauled to appropriate disposal site. Final remediation will be conducted in accordance with the NMOCD's Guidelines for Remediation of Spills, Leaks and Releases.
