
Describe Cause of Problem and Remedial Action Taken.\*

Solids control bin overflowed due to lack of communication of shutting the transfer pump off before the bin overflowed. There was discussion with all crews to be aware of communication and to watch the bin levels and turn the transfer pump off so that it does not run over the bin.

Area was approximately 2050 sq. ft. and clean was done by a vacuum truck.
