

Describe Cause of Problem and Remedial Action Taken.* Approximately 25 bbls of oil leaked from the flare onto location with approx. 20 bbls recovered. No fluids migrated off the location. B.O. back pressure valve on heater was replaced and remediation of the spill is underway.		
Describe Area Affected and Cleanup Action Taken.* The spill area on location will be excavated and sampled for Total Petroleum Hydrocarbons. All impacted soil will be stockpiled on poly-plastic and transported to an approve disposal facility. Clean material will be backfilled within the excavated area to normal grade. The impacted area located off location (oil sprayed vegetation) will be treated with Microbaze and monitored for vegetation growth. No soil was impacted off location.
