Please find attached an initial C-141 for a release that occurred August 9, 2014 on the Martha AIK Federal #6 flow line. It came to our attention yesterday that the Initial C-141 was completed on August 13, 2014, but failed to get submitted to your office. Initial TPH/BTEX/Chloride samples were taken on August 13, 2014, and we received the results back. Below, I've included a table summarizing the initial sample results. I am going to have a crew excavate this first 3' and then we will delineate the chlorides further. If more needs to be taken out after further sampling, we will submit a work plan to your office. If chlorides clean-up we will backfill, and we will submit a Final C-141 to your office.
