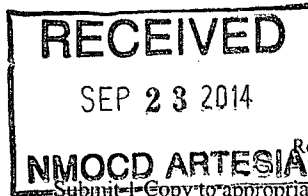

Crews repaired the line, impacted soils scraped up and hauled to an NMOCDC facility. **Depth to Ground Water: >100' (approximately 125' - 150', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on small amount released and site ranking of zero, Yates Petroleum Corporation requests closure.**
