
Describe Cause of Problem and Remedial Action Taken.* The produced water tanks overflowed, filled the steel containment then ran over onto the location. The caliche berms around the location contained most of the fluid to the location. A small amount of the fluid penetrated the berms and flowed from the East side of the location and into the pasture for approximately 100-feet. Talon personnel mobilized a backhoe to perform a site assessment and soil sampling.

Describe Area Affected and Cleanup Action Taken.* Talon/LPE was contracted for the correction of this release. The impacted area in the vicinity of S-1 was excavated to a depth of 5-feet bgs and a confirmation sample was taken from the bottom of the excavation to insure that all of the chloride impacted soil had been removed. The impacted area in the vicinity of sample locations S-2 and S-3 were excavated to a depth of 2-feet bgs. The impacted area in the vicinity of sample location S-4 was excavated to a depth of 1-foot bgs. The impacted area in the vicinity of S-5 was excavated to a depth of 5-feet bgs and a confirmation sample was taken from the bottom of the excavation to insure that all of the chloride impacted soil has been removed. All of the excavated material was disposed of at an NMOCD approved solid waste disposal facility, Lea Land LLC. The excavated area on the location was backfilled with caliche. The excavated areas in the pasture were backfilled with top soil, contoured to match the surrounding terrain and seeded with BLM seed mixture #1. Work completed pursuant to NMOCD approved work plan.


