The nipple on the discharge header at the west injection pump was off allowing 22 bbls of produced water to leak onto the ground. No fluids were recovered and the nipple was replaced.

The affected area is approximately 12' x 100' on location and 5' x 100' off location. Remediation will be completed in accordance with a remediation plan approved by NMOCD and the BLM.

This is to inform you that Oxy Permian Primary NM South had a leak at the Sand Dunes 28 Federal #1 SWD Battery on October 23, 2014. Oxy spilled 22 bbls of produced water due to a discharge header nipple being off on the west injection pump. The preliminary report shows the leak measuring approximately 12' x 100' on location and 5' x 100' off location. No fluids were recovered. The release is located in U/L J, Section 28, T23S, R31E of Eddy County, NM. BBC International will remediate the location at a later date and an initial C-141 will follow. Driving directions: From the intersection of CR29 (Red Rd.) and Hwy 128, go West on Hwy 128 for 3.5 miles to Pure Gold Road (mm14), turn left (South) on Pure gold Road for 0.7 mile, turn left (East) for 0.6 mile to location.
