Excess pressure caused the stuffing box packing on the wellhead to blow out 5 bbls of oil and 5 bbls of produced water onto the ground. No fluids were recovered and the stuffing box packing was replaced.

Describe Area Affected and Cleanup Action Taken.*

The affected area is approximately 30' x 60' on location. Remediation will be completed in accordance with a remediation plan approved by NMOCD and the BLM.

Subject: Lost Tank 3 Federal #21

This is to inform you that Oxy Permian Primary NM South had a leak at the Lost Tank 3 Federal #21 Battery on November 4, 2014. Oxy spilled 5 bbls of oil and 5 bbls of produced water due to excess pressure causing the stuffing box packing to blow out on the well head. The preliminary report shows the leak measuring approximately 30' x 60' with the leak staying on location. No fluids were recovered. The release is located in U/L E, Section 3, T22S, R31E of Eddy County, NM. BBC International will remediate the location at a later date and an initial C-141 will follow.
