
Describe Cause of Problem and Remedial Action Taken.*

A break in the heater line caused the release. Vacuum truck(s) and roustabout crew were called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 10'X 10' within the bermed and lined battery. The heater line was repaired and 100% of the released fluids were recovered using a vacuum truck. Depth to Ground Water: >100' (approximately 325', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on the battery is lined/bermed and all released fluids recovered, Yates Petroleum Corporation requests closure.
