

A leak in the butterfly valve caused the release. Vacuum truck(s) and roustabout crew were called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 80' X 20' within the bermed and lined battery. The release was stopped, the valve was repaired and 100% of the spill was recovered using a vacuum truck (s). Depth to Ground Water: >100' (approximately 125', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on the battery is lined/bermed and all released produced water recovered, Yates Petroleum Corporation requests closure.
