On October 28, 2014 Cimarex Energy Company ("Cimarex") filed an administrative application for an unorthodox horizontal well location and a 446.77-acre non-standard spacing unit/horizontal project area for its proposed Klein 33 Federal Com No. 6H. The non-standard spacing unit/horizontal project is to comprise the W/2 of Section 28 and Units C & D and Lots 3 & 4 (NW/4 equivalent) of Irregular Section 33, both in Township 26 South, Range 27 East. The surface, first take point and bottomhole locations for the Klein 33 Federal Com No. 6H were described in the original application as follows:

**Klein 33 Federal Com No. 6H** (API No. 30-015-42034)  
Surface Location: 210' FSL & 2020' FWL (Lot 3) Section 33  
First Take Point: 330' FSL & 2020' FWL (Lot 3) Section 33  
Bottomhole Location: 330' FNL & 2020' FWL (Unit C) Section 28

Due to surface obstructions, Cimarex has moved the surface and first take point locations for the Klein 33 Federal Com No. 6H a distance of approximately 20 feet west of the originally proposed surface and first take point locations. The bottomhole location will not change. **The Klein 33 Federal Com No. 6H will now be drilled at these locations (See Attached C-102):**

**Surface Location: 210' FSL & 2000' FWL (Lot 3) Section 33**  
**First Take Point: 330' FSL & 2000' FWL (Lot 3) Section 33**  
**Bottomhole Location: 330' FNL & 2020' FWL (Unit C) Section 28**

Discussions with Division personnel with regards to this well location change confirms that Cimarex will not be required to re-notify all parties entitled to receive notice of this application because the new well location is slightly less unorthodox than the originally proposed location.

Consequently, Cimarex requests that the non-standard well location order issued for the Klein 33 Federal Com No. 6H correctly identify the new surface and first take point well locations.






