The poly line busted, causing the release. Vacuum truck(s) and roustabout crew was called.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 10' X 10' around tin horns near a battery. The poly line was replaced and the vacuum truck removed standing fluid (18 B/PW). Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 10) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the OCD. **Depth to Ground Water: 50-99' (approximately 50-75', per ChevronTexaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 10.**
