Pursuant to Division Rule 19.15.15.13, *Enervest Operating, LLC* ("Enervest") respectfully requests administrative approval of an unorthodox gas well location for its proposed Jicarilla B No. 2F. This well will be drilled as a development gas well in the Blanco-Mesaverde (Prorated Gas-72319) and Basin-Dakota (Prorated Gas-71599) Gas Pools at an unorthodox location for both pools 2047 feet from the South line and 1690 feet from the West line (Unit K) of Section 16, Township 26 North, Range 5 West, NMPM, Rio Arriba County, New Mexico.

The proposed Jicarilla B No. 2F will be dedicated to existing 320-acre gas spacing and proration units in both the Blanco-Mesaverde and Basin-Dakota Gas Pools comprising the S/2 of Section 16. **In the Blanco-Mesaverde Gas Pool**, this unit is currently dedicated to Enervest's existing: i) Jicarilla B No. 2 (API No. 30-039-08135) located at a standard well location 815 feet from the South line and 845 feet from the West line (Unit M); and ii) Jicarilla B No. 2M (API No. 30-039-29914) located at a standard well location 1190 feet from the South line and 2630 feet from the East line (Unit O). The Jicarilla B No. 2F will be the second infill well on this unit. **In the Basin-Dakota Gas Pool**, this unit is currently dedicated to the above-described Jicarilla B No. 2 and Jicarilla B No. 2M, and to Enervest's existing Jicarilla B No. 2E (API No. 30-039-22579) located at a standard well location 1640 feet from the South line and 1520 feet from the East line (Unit J). The Jicarilla B No. 2F will be the third infill well on this unit.

Both the Blanco-Mesaverde and Basin-Dakota Gas Pools are currently governed by special rules established by Order No. R-10987, as amended. Pursuant to these rules, wells are to be located no closer than 660 feet to the outer boundary of the spacing unit nor closer than 10 feet to any quarter-quarter section line or subdivision inner boundary. These rules also allow the drilling of up to four wells within a standard spacing unit provided that no more than two wells may be drilled within a quarter section, and further provided that no more than one well may be drilled within a quarter-quarter section.

The attached map shows that the proposed unorthodox location is necessary due to surface topography in this area.

The affected offset tract is the N/2 of Section 16, which is an existing 320-acre spacing unit in both the Blanco-Mesaverde and Basin-Dakota Gas Pools. This unit is currently operated by Enervest. Please note that the working interest ownership between the N/2 and S/2 of Section 16 is common. Consequently, notice of this application is not required to working interest owners in the N/2 of Section 16.

Attached is a Form C-102 for both the Blanco-Mesaverde and Basin-Dakota Gas Pools showing the proposed well, spacing unit, other existing wells in the spacing unit and the affected offset acreage. Also attached is a topographic map.

In summary, approval of the application will provide Enervest the opportunity to recover additional oil and gas reserves from the Blanco-Mesaverde and Basin-Dakota Gas Pools underlying the S/2 of Section 16 that may otherwise not be recovered by the existing wells, thereby preventing waste, and will not violate correlative rights.


