The driver did not have a tarp installed on top for transport. The driver was instructed to inform his supervisor of the spill and have a replacement tarp sent to location before he would be allowed to leave location with the bin.		
Describe Area Affected and Cleanup Action Taken.*		
Area was approximately 8' x 7' x .5". All solids were shoveled up along with the affected dirt and put back in to the solids bin and disposed of.
