

Describe Cause of Problem and Remedial Action Taken.\*

Due to low temperatures, hydrates formed at various locations along the pipeline. A natural gas blowdown occurred as part of the hydrate removal activity. No liquids were produced during this event, and no pipeline repairs were necessary.

No liquid spills occurred requiring any cleanup actions.
