The production tank overflowed, causing the release. Vacuum truck(s) were called.

Describe Area Affected and Cleanup Action Taken.\*

An approximate area of 60'X 120' within the lined/bermed battery. The valves were closed and the spill was recovered using a vacuum truck. Impacted soils excavated/hailed to a NMOCD approved facility. Depth to Ground Water: < 25' (approximately 25', per Chevron/Texaco Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 20. Based on the battery being lined/bermed and all released crude oil recovered, Yates Petroleum Corporation requests closure.
