On behalf of Energen Resources Corporation ("Energen") and pursuant to Division Rule 19.15.15.13 and the applicable rules governing the acreage and well location requirements for the West Lindrith Gallup-Dakota Oil Pool (39189; Order No. R-4314-A), we request administrative approval for the unorthodox well location for the Chacon Jicarilla Well No. 602-H to be drilled at the surface and bottom hole locations indicated above in a standard 320 acre horizontal well oil spacing and proration unit comprised of the S/2 of Section 22, Township 23 North, Range 3 West, NMPM, Sandoval County.

Energen seeks an exception from the applicable well location rules for the following reasons: Order No. R-4214-A established amended special pool rules for the West Lindrith Gallup-Dakota Oil Pool with 160 acre spacing units to be comprised of a quarter section with well locations at least 330' from the outer boundary of the proration unit and no nearer than 660' to a well drilling or capable of producing from the same pool.

Operator experience has established that horizontal oil wells with maximum lateral length will be necessary to efficiently recover all the reserves in the unit. (See Exhibit A.) In this case the well's Completed Interval will be approximately 200' from the outer boundaries of the west and east sides of the S/2 unit, making this application for an exception necessary. There is no other well located within 660' that is being drilled or capable of producing from the same pool. The C-102 plat showing the S/2 Project Area comprised of two standard 160 acre proration units and the proposed location for the Chacon Jicarilla Well No. 602-H is attached as Exhibit B.

In accordance with Division Rules 19.15.4.12 A(2) notification is being provided to those offset interest owners or operators in adjoining spacing units reflected on Exhibit C. Energen Resources Corporation owns and operates the adjoining units in the S/2 N/2 of Section 22, the SE/4 SE/4 of Section 21 and the N/2 N/2 of Section 27 under a single BIA lease. The SW/4 SW/4 of Section 23 is a separate Jicarilla Nation lease, also 100% owned and operated by Energen. The Bureau of Indian Affairs, Jicarilla Nation Oil and Gas Administration and the Bureau of Land Management are being notified of this application.

SPECIAL RULES FOR THE  
WEST LINDRITH GALLUP-DAKOTA OIL POOL

RULE 1. Each well completed or recompleted in the West Lindrith Gallup-Dakota Oil Pool or within one mile thereof and not closer to another Gallup-Dakota pool shall be spaced, drilled, operated, and produced in accordance with the Special Rules hereinafter set forth.

RULE 2. Each well shall be located on a standard unit containing 160 acres, more or less, substantially in the form of a square, which is a quarter-section being a legal subdivision of the United States Public Land Surveys.

RULE 3. The Director of the Division may grant an exception to the requirements of Rule 2 without notice and hearing when an application has been filed for a non-standard unit consisting of less than 160 acres or the unorthodox size or shape of the tract is due to a variation in the legal subdivision of the United States Public Land Surveys. All operators offsetting the proposed non-standard unit shall be notified of the application by registered or certified mail, and the application shall state that such notice has been furnished. The Director may approve the application upon receipt of written waivers from all offset operators or if no offset operator has entered an objection to the formation of the non-standard unit within 30 days after the Director has received the application.

RULE 4. Each well shall be located no nearer than 330 feet to the outer boundary of the proration unit or to any governmental quarter-quarter section line nor nearer than 660 feet to the nearest well drilling to or capable of producing from the same pool; provided however,

a. A boundary area is hereby created consisting of a band one-half mile wide extending from the pool boundary to a line one-half mile inside said boundary.

b. No well completed or recompleted in said boundary area shall be drilled closer than 790 feet to the pool boundary nor closer than 130 feet to the interior quarter-quarter section line unless a direct
