

The facility was shut in and the line was replaced. A vac truck recovered 1.5 barrels of fluid. Talon/LPE was contracted to perform an initial site assessment and soil sampling.		
Describe Area Affected and Cleanup Action Taken.* The area affected is in front of the LACT unit measuring approximately 60-feet long and 30-feet wide. All fluids remained on location.
