The project area for these wells include the E/2 E/2 of Section 11, and the E/2 E/2 of Section 14, Township 21 South, Range 33 East, NMPM, Lea County, New Mexico

The commingled oil and gas production from the wells detailed above shall be measured and sold at the Cranberry BSU State Com. No. 1H central tank battery (CTB), located in Unit P, of Section 11, Township 21 South, Range 33 East, NMPM, Lea County, New Mexico.

The oil and gas production from each well shall be continuously measured with allocation meters before commingling with production from other wells. The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

It is our understanding that notice of this application has been provided to all owners of interest in the subject wells. No objection has been received by the Division during the objection period.

The operator shall notify the Hobbs District office of the Division prior to implementation of the commingling operations.

This approval is subject to like approval from the New Mexico State Land Office before commencing commingling operations.
