Dear Director Bailey:

Concho Resources Inc., acting through COG Operating LLC, protests the application of Owl SWD Operating, LLC for an open hole commercial salt water disposal well, specifically the McCloy SWD Well No. 1.

The proposed disposal interval will be through open hole from 4850 feet to 7300 feet in the Delaware formation. In support of its proposal COG initially notes that many portions of the Delaware are productive for oil and gas. COG is planning production from this same depth for its Foxglove area and believes the open hole disposal in the same zone will impair its ability to produce oil and gas which wastes the hydrocarbons and denies COG its opportunity to produce oil and gas.
