

Describe Cause of Problem and Remedial Action Taken.\*

This release was caused when a flowline was damaged after heavy equipment ran over the line. Vacuum trucks were dispatched to recover all standing fluid and dispose of at an NMOCD approved facility.

Describe Area Affected and Cleanup Action Taken.\*

The affected area was the pasture to the north of the lease road. Concho will have the spill site sampled to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
