

This is a request for administrative approval for a non-standard gas well location in the Basin Aztec Pictured Cliffs pool. The Cain 100 will be a Fruitland Coal and Aztec Pictured Cliffs commingled well. The well is staked standard for the Fruitland Coal formation.

The Cain #100 was staked at an unorthodox location due to terrain and endangered plants. Endangered plants (Brack's Cactus) and rugged terrain encompass the majority of the area within the legal spacing window for the Pictured Cliffs formation. The original staked location was 1705' FSL & 865' FWL (legal window), but during the onsite inspection with the BLM the endangered Brack's Cactus was found and the location had to be moved. As a result, no suitable location could be found within the window. Consequently, this location was staked non-standard for the Pictured Cliffs formation, to best fit the terrain and Endangered plants. Production from the Pictured Cliffs is included in the 182.16 acre gas spacing unit, with lots 6, 10, 11, 12 13 and E/2NW/4 dedication of Section 30, T29N, R9W.
