

The lines were cut and capped. A vac truck was immediately called to the site and recovered 300 barrels of produced water and 1 barrel of oil. Talon/LPE was contacted for the emergency response.**

Describe Area Affected and Cleanup Action Taken.* **Talon mobilized personnel and equipment for emergency cleanup and sampling.**
